## **Terms and Conditions**

## **Entry Details:**

- This document contains the terms and conditions of entry and the prizes forming the 2022 Junior Member Colouring Competition (Promotion). Participation in this Promotion is deemed acceptance of these Terms and Conditions.

- 3. Promotion commences at commences at 9:00am, 11 October 2021 and closes at 11:59pm, 31 December 2021 ("Promotional Period"). All times indicated in these Terms and Conditions are in AWST.

- 5. The Winner will be determined by the following judging criteria:
  - a. This is a game of skill. Each entry will be judged by a representative of the Promotor. Each entry will be judged on the basis of individual creative merit of the submission ("Judging Criteria").

Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin.
